10. MONITORING PROGRESS & ANNUAL ACCESSIBILITY PLANS

This working group will act as both the technical advisor to Council and as a liaison to the special needs community. They will meet annually to review the accessibility plan as well as monitor project status to ensure that the goals and objectives of this plan and of the Ontarians with Disabilities Act, 2001 are being accomplished.

The Municipal Accessibility Plan Committee met on June 2, 2008 at East Ferris Township offices to update the Municipal Accessibility Plan as mandated. The committee is comprised of these members;

Robert Point- Co- Chair, Rick Champagne- Co-Chair, Paul Gervais- Secretary and Angela Hurrell-Member. Mr. Champagne was absent from the meeting, John Fior attended the meeting.

The meeting dealt with updating the barriers that were identified in the original plan as well as newly identified barriers.

1. Meeting called to order at 7:15

2. Old Business;

(i) Carnival book/program

There was no advertisement in the Winter Carnival program for transportation of people with disabilities as expected. The committee will send a letter to the Carnival Committee to remind them to provide some arrangement to transport people with disabilities to the East Ferris Winter Carnival next year.

- (ii) Update of what's been accomplished in 2007
 - (a) The shortage of Senior's housing is being addressed and is underway.
 - (b) Signage for B-F parking has been installed at the Corbeil Park Hall, however, the committee has concerns about the installation since the designated area (close to the entrance of the hall) may be a hazard in case of an emergency evacuation of the building, also, drivers are forced to reverse out of the lot which may prove difficult for some and cars parked in the area will make it difficult for emergency responders (ambulance, fire department etc...). The committee will send letters to Council and the East Ferris Golden Age Club asking that the area closest to the entrance to the hall be designated as a loading zone. Also, there is still no designated B-F parking at the municipal office.

4. New Business

Resolution No. 4 from council (May 12/08 meeting) re: Ontario Regulation 429/07 (Accessibility Standards for Customer Service).

The resolution by Council, report by Paul Gervais and the regulation was discussed by the committee. The committee thought that since other municipalities have to comply as well, that it would be a good idea to pool the resources of several area municipalities to create a framework policy that all municipalities could use or alter to suit their needs. It was therefore suggested that this proposal be brought to Bill Vrebosch so that he could bring it to the next Mayor's meeting.

The committee also realized that Ontario Regulation 429/07 (Accessibility Standards for Customer Service) will remove the responsibility (from this committee) to inform and educate local businesses since the province will educate businesses as well as enforce the regulation.

5. Recommendations to Council

The committee is sensitive to the Housing Needs Study underway for the municipality's facilities and council's hesitation to cause renovations that would later become redundant. It is for this reason that many of the recommendations for municipal facilities were not updated. It is hoped that the Housing Needs Study will address the concerns of this committee and the requirements of Ontario Regulation 429/07 (Accessibility Standards for Customer Service).

The Committee wanted to make Council aware of the following concerns and makes the following recommendations to Council:

- 1. Angela Hurrell has offered to meet with Bob Mills at the arena and the government dock to discuss what corrections should be made.
- 2. Signage inside the Municipal Office is still required to be installed.
- 3. The washrooms at the Government Dock Beach on Big Moose Road need to be completed and or corrected.
- 4. Toilet paper holders in the B-F washroom of the Corbeil Park Hall is too high, as are those in the renovated stalls of the arena.
- 5. Accessible parking areas should be designated at the Municipal office and Astorville Fire hall.

- 6. The difficulty of audibility at meetings for the hearing impaired is still an issue.
- 7. Since the washrooms on the main floor of the arena have been corrected (and there are still minor issues with them), the washrooms at the upper floor should be corrected.
- 8. That other municipal web sites be checked for accessibility plans and/or policies that address Ontario Regulation 429/07 (Accessibility Standards for Customer Service).
- 9. That area mayor's be made aware of the requirements of Ontario Regulation 429/07 (Accessibility Standards for Customer Service) in the hopes of finding volunteers to create the required policy.

5. Adjournment

The committee is to meet again in late summer or early fall. The meeting was adjourned at 9:00 p.m.
